**TUITION IS A MONTHLY FLAT RATE** PAID PER SESSION AUGUST THROUGH JUNE. PLEASE NOTE: DECEMBER (SESSION 5) AND JUNE (SESSION 11) HAVE 3 WEEKS OF CLASSES AND ARE NOT PRORATED. PAYMENT CAN BE MADE FOR THE DANCE YEAR IN FULL (15% DISCOUNT, 1 PAYMENT), EACH SEMESTER IN FULL (10% DISCOUNT, 2 PAYMENTS) OR BE DIVIDED INTO PAYMENTS PER SESSION (NO DISCOUNT, 11 PAYMENTS). YOU CAN MAKE-UP A MISSED CLASS BY ATTENDING AN ALTERNATIVE CLASS AND THIS IS STRONGLY RECOMMENDED.

**ALL COMMITMENT PROGRAM ACCOUNTS ARE REQUIRED TO HAVE A CREDIT OR DEBIT CARD ON FILE TO RECEIVE COMMITMENT PROGRAM TUITION RATES. CASH, CHECK, OR DEBIT-CLIENT ACCOUNTS ARE SUBJECT TO REGULAR TUITION RATES.** ALL TUITION PAYMENTS ARE DUE AND/OR WILL BE AUTOMATICALLY CHARGED ON THE 1<sup>ST</sup> OR 15<sup>TH</sup> OF EACH MONTH FROM AUGUST THROUGH JUNE, UNLESS TUITION HAS BEEN PAID BY THE 25<sup>TH</sup> OF THE PRIOR MONTH. (IF CASH, CHECK OR CREDIT CARD PAYMENT HAS BEEN PROCESSED BY THE 25<sup>TH</sup> OF THE PRIOR MONTH THE CREDIT CARD ON FILE WILL NOT BE CHARGED.) IF A PAYMENT IS RECEIVED BETWEEN THE 25<sup>TH</sup> AND THE 1<sup>ST</sup>, THE PAYMENT WILL BE APPLIED TO THE NEXT MONTH'S TUITION. **WE DO NOT SEND STATEMENTS AND A LATE FEE OF \$20** WILL BE CHARGED IF, **FOR ANY REASON**, TUITION IS NOT PAID **10 DAYS AFTER** THE DUE DATE (APPLIED ON THE 10<sup>TH</sup> OR 25<sup>TH</sup> OF THE MONTH). ONCE A STUDENT WITHDRAWS AND BECOMES INACTIVE THE CARD WILL NO LONGER BE CHARGED. (SEE WITHDRAWAL POLICY BELOW FOR CLARIFICATION).

IF A STUDENT NEEDS TO DROP A CLASS, A **DROP FORM MUST BE COMPLETED**. IF A STUDENT NEEDS TO WITHDRAW FROM ALL CLASSES, A **WITHDRAWAL FORM MUST BE COMPLETED**, AS TUITION WILL CONTINUE TO ACCUMULATE UNTIL THE DROP/WITHDRAWAL FORM HAS BEEN COMPLETED AND SIGNED. **THE CHANGES BECOME EFFECTIVE THE FIRST OF THE FOLLOWING MONTH.**
